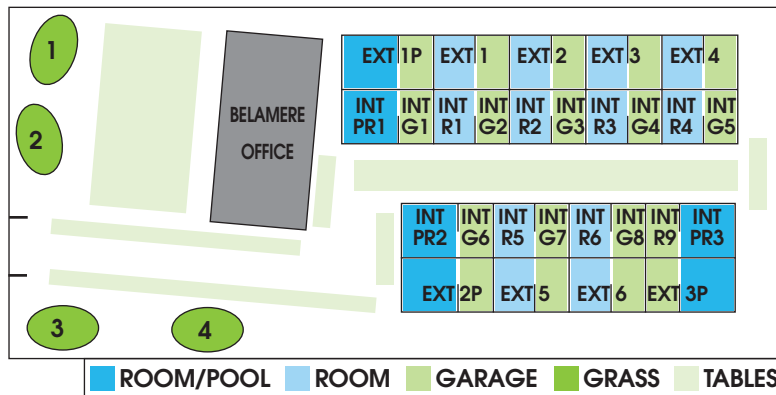

This document when signed by Exhibitor and Belamere Suites/Journey to a Healthier You! constitutes a binding legal agreement Belamere Suites/Journey to a Healthier You! agrees to assign to your company exhibit space. The Exhibitor agrees that upon acceptance of this Contract by Belamere Suites/Journey to a Healthier You!, with or without appropriate payment, this Application and Contract shall become a legally binding contract enforceable against the Exhibitor in accordance with its terms. By signing this document, the individual signing represents and warrants he/she is duly authorized to execute this binding contract on behalf of the exhibitor.

PAYMENT: On credit approved accounts; charges for services under this contract are due and payable by July 16, 2010, unless otherwise specified. Prepayment is required by advertisers/exhibitors until credit is approved by Belamere Suites/Journey to a Healthier You!.

EXHIBIT SPACE: Exhibit space is based on the type of space selected, space selection will be handled on a first-come, first-served, space-available basis. This Contract for exhibit space at the Journey to a Healthier You! 1st Annual Health & Wellness Retreat will not be processed if an illegible, incomplete or an unsigned Contract is submitted. Only the company name listed on this Contract is considered an official Exhibitor, under no circumstances will the Exhibitor be permitted to occupy its exhibit space if full payment has not been received.

OCCUPANCY BY EXHIBITOR: It is further agreed that actual occupancy of the space reserved by the Exhibitor is of the essence. Exhibitors may occupy their exhibit space after 12 PM on Saturday July 31, 2010. If the Exhibitor does not occupy the space, Belamere Suites/Journey to a Healthier You! may occupy or cause said space to be occupied as it may deem best for the interest of Belamere Suites/Journey to a Healthier You! without in any way releasing the Exhibitor from any liability hereunder. Furthermore, if the Exhibitor does not occupy/staff the space all rights of said Exhibitor will be revoked. Premature dismantling of and/or failure to fully staff said space during the entire show will result in the forfeiture of the exhibit space.

EXHIBIT SETUP: No refund will be made to any Exhibitor for spaces assigned and not occupied by 12 PM on Saturday July 31, 2010. Floor plans provided by Belamere Suites/Journey to a Healthier You! are believed to be correct and encourages Exhibitors to verify floor plans directly by confirmation.

CANCELLATION BY EXHIBITOR: All cancellations must be in writing if a return receipt is requested and shall become effective when received and signed by Belamere Suites/Journey to a Healthier You!. Belamere Suites/Journey to a Healthier You! must receive written cancellation by no later than Friday, July 16, 2010 to qualify for the full credit and/or refund. Both the Exhibitor and Belamere Suites/Journey to a Healthier You! acknowledge that Belamere Suites/Journey to a Healthier You! will sustain losses if the Exhibitor cancels its Application and Contract after this date, therefore all payments made or due to Belamere Suites/Journey to a Healthier You! shall be fully earned and non-refundable, in consideration for expenses incurred by Belamere Suites/Journey to a Healthier You! and its lost or deferred opportunity to provide exhibit space to others.

OPERATION OF EXHIBITS: Exhibits must be designed and operated in a manner that respects the rights of other exhibitors and visitors. Personnel must confine their activities to the exhibit space of the Exhibitor by whom employed. Exhibitors are responsible for payment of fees, royalties or fines for use of work that is protected by copyright patent or trademark and must be staffed at all times during scheduled exhibitions. Booth personnel must be 16 years of age or older. Belamere Suites/Journey to a Healthier You! reserves the right to refuse any advertiser/exhibitor.

LIABILITY AND INSURANCE: The Exhibitor and its authorized contractors agree to carry general liability insurance, property insurance to sufficiently cover exhibitor's property and contents and workers' compensation insurance. Exhibitors agree to indemnify and hold harmless Belamere Suites/Journey to a Healthier You! and related subsidiaries, their contractors, officers, agents and employees against all claims, losses, suits, damages, judgments, expenses, costs and charges of every kind, including attorneys' fees resulting from its occupancy of the exhibit space contracted for, by reason of personal injuries, death or property damages sustained by any person. Certificates of insurance must be furnished by Exhibitor if requested by Belamere Suites/Journey to a Healthier You! and must be available on-site during the show. Failure by Belamere Suites/Journey to a Healthier You! to request proof of insurance shall not relieve Exhibitor from carrying proper coverage. The Exhibitor understands neither Belamere Suites/Journey to a Healthier You! and subsidiaries maintains insurance covering the Exhibitor's property and it is the sole responsibility of the Exhibitor to obtain such insurance.

RESPONSIBILITY FOR PROPERTY: In no case will Belamere Suites/Journey to a Healthier You! be responsible for theft, loss or damage to Exhibitor's product or booth. Exhibitor agrees it is wholly responsible for protecting its property on show premises. Exhibitors are encouraged to secure their exhibits and products and should insure their property (from the time it leaves their business until it returns) at their own expense.

RECEIPT AND REMOVAL OF FREIGHT: No exhibit or portion thereof may be removed from the exhibit during the event. Only Exhibitors showing proper exhibit credentials and personal identification will be permitted to take merchandise out of the facility. If any Exhibitor fails to remove its freight in the allotted move-out time, Belamere Suites/Journey to a Healthier You! reserves the right, at the Exhibitor's expense, to ship the Freight through a carrier of its own choosing.

EXHIBIT CONSTRUCTION DECORATION, SIGNS, ETC.: Exhibitors remain solely liable for the safety of their exhibit. All bunting, draperies or other Fabrics must be fireproofed before use in the decoration of any exhibit.

FORCE MAJUER: In the event the Journey to a Healthier You! is delayed, rescheduled or cancelled due to an occurrence beyond the control of Journey to a Healthier You!, including but not limited to an Act of God, war, catastrophic event or the conduct of third parties, then this agreement shall continue in full force and effect during any delay or as scheduled, and shall terminate if cancelled, with all sums paid by Exhibitor refunded. If the event must be delayed due to inclement weather the event will be held on the next available Saturday.
